A. AB 2018-24, Ordinance No. 762, Franchise Agreement

B. AB 2018-25, Ordinance No. 763, Cable Franchise Agreement

A draft cable franchise agreement for Charter Communications was presented for a first reading. Councilman Fred Netzel had several questions, suggested a few changes and requested the 2nd reading and intent to adopt the Ordinance be advertised to the public. Ben Alling moved and Marcia Warnecke seconded to accept the first reading of Ordinance No. 763 and Franchise Agreement with changes. Motion carried.

A. Varela & Associates Project Updates

Engineer Daniel Cowger provided an update on the Wastewater Treatment Project and provided a slideshow of the progress. The project is within budget with approximately \$375,000 of project budget remaining.
